2. This letter of intent shall be applicable to educational and research organization attached to each party.


3. This letter of intent constitutes the entire agreement between the parties and all prior discussion, agreements and understandings, whether verbal or in writing, are merged in this agreement.


4. This letter of intent is not considered to be a contract creating legal and financial relationships between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial exchange process/ research relationship and so forth

5. This letter of intent shall become effective as of the date of signature of the parties. It may be amended by the written consent of the parties
6. This letter of intent should be reviewed every year to evaluate the progress and the quality of the mutual cooperation. It may be extended for additional five year periods upon the written consent of both parties. If the letter of intents not renewed by mutual consent, then it will conclude at the end of the specified time period, or after activitiesin progress have concluded.
7. This letter of intent may be terminated by either party with a minimum of 120 days written notice. Activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed.
8. Both institutions subscribed to a policy of equal opportunity and will not discriminate on the basis of race, religion, color, sex, age, national origin or ancestry, marital status, parental status, disability, or veteran status
